#### Dear Mr. Carrasco:

This letter is to inform you that at our meeting on July 10, 2008, the Granada Hills South Neighborhood Council ("GHSNC") took action rescinding its earlier June 13, 2008, letter addressed to your attention and approved sending a corrected letter conveying our board's position. In our June 13, 2008, letter we stated:

"GHSNC in a desire to support the equestrian, elderly and youth users of the Mario Decampos trail request that The Gas Company consider moving a small portion of their fence to allow easier access to Mission Point. John Seletos (GHSNC Board Member) is willing to exchange property that he owns in the Lankershim Ranch area (APN 2336-019-009) for the land requested which will then be donated for public use. GHSNC is willing to provide up to \$5,000 to The Gas Company for repositioning of their fence (Pending DONE approval)"

This letter clarifies our position that GHSNC, in a desire to support the equestrian, elderly and youth users of the Mario Decampos trail requests that The Gas Company consider moving a small portion of its fence to allow easier access to Mission Point and the GHSNC is willing to provide up to \$5,000 to The Gas Company for repositioning the fence. If the Gas Company is amenable to this request please let us know by \_[insert date]\_\_\_\_, 2008. Any expenditure of funds, up to \$5,000, to assist in repositioning the fence will then need to be approved by the Department of Neighborhood Empowerment and, as soon as we are informed of your decision, we can begin working on the necessary paperwork.

We look forward to working with you on this endeavor and appreciate your kind consideration of the values important to our community.
