Note that any stakeholder comments must be made during the appropriate public comment period, and either during an individual's allotted time or if an individual stakeholder has been invited to speak by a board member. Audience members may not approach the board during a meeting except to hand out materials during the allotted speaking time, and then only with the permission of the presiding officer. If a stakeholder has any requests that cannot be addressed during the allotted speaking time, the items may be e--mailed to the board or to our Secretary.

Note that Government Code section 54957.9 provides: In the event that any meeting is willfully interrupted by a group or groups of persons so as to render the orderly conduct of such meeting unfeasible and order cannot be restored by the removal of individuals who are willfully interrupting the meeting, the members of the legislative body conducting the meeting may order the meeting room cleared and continue in session. Only matters appearing on the agenda may be considered in such a session. Representatives of the press or other news media, except those participating in the disturbance, shall be allowed to attend any session held pursuant to this section. Nothing in this section shall prohibit the legislative body from establishing a procedure for readmitting an individual or individuals not responsible for willfully disturbing the orderly conduct of the meeting.

Please note further that Penal Code section 403 states: Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is not unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Section 18340 of the Elections Code, is guilty of a misdemeanor. The board reserves its rights to exercise appropriate remedies in the event of disruption of board or committee meetings.

Motion 1

The Granada Hills South Neighborhood Council supports the motion made by Councilmembers Mike Bonin and Paul Koretz which requests the Los Angeles Department of Water and Power (DWP) model a 100% renewable energy scenario in the 2018 Integrated Resource Plan {IRP}.

Given the large scope of 100% renewable energy future and the impacts renewable energy will have to clean our air, improve the health of our communities, and require investment and support from ratepayers, the 2018 IRP should be an opportunity to bring this to public discussion. Further, we support excluding biomass, biogas and nuclear energy from the model. These fuels are controversial and do less to support human health, a safe climate and environment than true clean energy alternatives such as solar, wind, geothermal and hydro.

We the Stakeholders in the Granada Hills community find the DWP has failed to maintain infrastructure of the system, judiciously shepherd rates for water and power for all ratepayers in the city of Los Angeles and failed to hold itself accountable to its' own strategic plan. We demand the elected leaders of this city take appropriate action to correct these deficiencies.

Motion 2

The Granada Hills South Neighborhood Council calls upon the Los Angeles City Council to replace the current iteration of Section 85.02 of the Los Angeles Municipal Code with a section that protects public's right to decide how to utilize commonly funded, public space; protects the environment, protects the public health, and protects the rights of business owners in areas adversely effected.

RECOMMENDATIONS

- Find, publish and maintain a list of availability of locations within SPA 2 which are
 designed to support RV's. Ensure that the number of available spaces is updated on
 a regular basis.
- After the appropriate vetting process, use funds that would have been made available to Safe Parking lots to bridge subsidize RVs parking at legitimate RV compatible locations within SPA 2.
- Utilize monies from Proposition H and HHH to find and develop RV parks with sanitation hookups or waste disposal. This has to be cheaper than the current estimates of \$400,000 per unit that is being told to the community at public meetings.
- Any Ordinance that allows for the use of a public street or parking lot for use as a
 domicile for any length of time must get the approval of a supermajority of the
 owners and tenants of the area proposed.
- Enforcement of the ordinance should be available via Administrative Citation, Infraction Citation, and Parking Citation.
- The law should provide yearly funding for Sanitation Crews and Towing interests to remove eligible vehicles from the roadway or parking lot on the day that impound is requested.
