Re. Community Impact Statement

The Granada Hills South Neighborhood Council requests that the Los Angeles City Council address the use of Los Angeles City Parks as emergency homeless shelters. On May 18th 2020 the Mayor of Los Angeles Eric Garcetti announced that due to the COVID-19 Pandemic the City of Los Angeles would begin using Los Angeles Recreation Centers as Emergency Homeless Shelters.

The Mayor's announcement appeared to be devoid of an exit strategy with the use of Recreation Centers as Emergency Homeless Shelters. The Mayor's announcement did not provide a template or plan for Neighborhood Councils or the Public to follow with regard to Sanitation, Public Safety, Emergency Services or a conduit for the Public to report issues with the Emergency Homeless Shelter program.

Currently the residents of Granada Hills have witnessed an unacceptable increase in homeless encampments at and beyond the Granada Hills Recreation Center (Petit Park). Persons experiencing homelessness have moved beyond Petit Park and can now be found living throughout the Granada Hills South Neighborhood Council's boundaries.

WHEREAS Granada Hills (Petit) Park that is located within the Granada Hills South Neighborhood Council's boundaries is important for the wellbeing of over 53,000 residents of Granada Hills.

WHEREAS Residents of our part of Los Angeles, including persons experiencing homelessness the city has transferred to Granada Hills Park, deserve dignity and a safe community environment.

WHEREAS The City of Los Angeles has physically transferred numerous Angelinos experiencing homelessness to Granada Hills and, due to that transfer, the City of Los Angeles is now directly responsible for the lives of those Angelinos experiencing homelessness.

WHEREAS, Using our City Park – Granada Hills Park has resulted in increased encampments in and around the park at an unacceptable level, including impeding access to the Public Library located at the Southeast corner of Chatsworth Street and Petit Avenue.

WHEREAS The City of Los Angeles must provide a written strategy and the results of that strategy for providing, Safety, Sanitation and Services for the individuals experiencing homelessness and to the neighborhoods they have moved into.

WHEREAS The City of Los Angeles has transferred Los Angeles Residents that are experiencing homelessness to Granada Hills and therefore must provide a safe environment for those persons 24 hours a day 7 days a week. This includes persons that have moved beyond Petit Park. The LAPD has provided security at Petit Park and must seek out and help safeguard the lives of the homeless at and beyond the Park.

THEREFORE,

BE IT RESOLVED that the Granada Hills South Neighborhood Council strongly requests

- 1. The City of Los Angeles should provide our community with an accounting of how many Angelinos experiencing homelessness have been transferred to the Granada Hills Recreation Center.
- 2. The City of Los Angeles must ensure that all persons experiencing homelessness that have been placed at Granada Hills Park are provided with services to ensure successful placement in other housing once the facility is no longer available as a shelter.
- 3. The City and County of Los Angeles must ensure that all persons experiencing homelessness in the community surrounding Granada Hills Park are provided with services to ensure successful placement in other housing once the facility is no longer available as a shelter.
- 4. Request for Los Angeles City and County Sanitation to provide ongoing cleaning and portable restroom facilities in the areas around the new homeless encampments that have appeared at and near Granada Hills Park.
- 5. Request for Los Angeles City to assess the use of unarmed specialists to respond to non-violent emergency calls in Granada Hills including, health, mental health and substance abuse. The Los Angeles City to respond in writing to GHSNC by September 1, 2020.
- 6. Request for the City of Los Angeles to provide effective police presence to ensure the safety and security of both persons experiencing homelessness on the streets of Granada Hills and to the surrounding community.
- 7. Request for the City of Los Angeles to provide a strategy to ensure that the Los Angeles Police Department work with LAHSA to use every tool necessary to deescalate any situation involving a person experiencing homelessness within the boundaries of the Granada Hills South Neighborhood Council rather than resort to use of force.
- 8. Request that any use of force by the LAPD against any person experiencing homelessness within the boundaries of Granada Hills South be immediately reported to the Granada Hills South Public Safety and Homelessness Committees.

9.Request that City Councilmember John Lee and Supervisor Kathryn Barger provide an ongoing monthly report to both the GHSNC Homelessness Committee and the GHSNC Safety Committee of the services being provided to persons experiencing homelessness on the streets of Granada Hills by LAHSA, DMH, Dept. of Sanitation, LAPD and any other city/county funded entities.
