In the event that any meeting is willfully interrupted by a group or groups of persons so as to render the orderly conduct of meeting unfeasible and order cannot be restored by the removal of individuals who are willfully interrupting the meeting members of the legislative body conducting the meeting may order the meeting room cleared and continue in session. matters appearing on the agenda may be considered in such a session. Representatives of the press or other news m except those participating in the disturbance, shall be allowed to attend any session held pursuant to this section. Nothing i section shall prohibit the legislative body from establishing a procedure for readmitting an individual or individual responsible for willfully disturbing the orderly conduct of the meeting.

Please note further that Penal Code section 403 states:

Every person who, without authority of law, willfully disturbs or breaks up any assembly or meeting that is unlawful in its character, other than an assembly or meeting referred to in Section 302 of the Penal Code or Se 18340 of the Elections Code, is guilty of a misdemeanor.

The board reserves its rights to exercise appropriate remedies in the event of disruption of board or committee meetings.
