Motion PASSED with 11 in favor, 1 in opposition and 1 abstention.

Discussion and possible action to lease office and storage space at 10718 White Oak Ave. Motion to Look into the office space made my Mr. Beauvais 2nd by Ms. Crawford-Velasco. Motion PASSED with 7 in favor, 1 in opposition and 3 abstentions.

Budget Committee (Brandon Schindelheim, Chair)

Reallocation of Funds for the remainder of the fiscal year. Motion From Committee as presented by the Treasure. Motion PASSED by Unanimous Vote.

Public Safety Committee (Bob Stevens, Chair)

Allocation of an additional \$100 and application of remaining refreshment funds to purchase vests and helmets for CERT class graduates. Mr. Rivas added that the costs of supplies fell within the total previously allocated. Motion dropped.

Ad-Hoc Food Truck Committee (Sean Rivas, Chair)

Report on Cell Tower on San Fernando Mission Blvd. between Amestoy and Louise. Mr. Askew reported that there was an appeal hearing before the Board of Public Works and T-Mobile withdrew their application.

Mrs. Fisk reported that since 2007 there have been 25 hearings on the Community Care Ordinance.
