Review and approval of US Bank purchasing card transactions, bank statements and budget report. Brandon Schindelheim, Treasurer, reported that we have

Probable date/location: February 21 or 23 at Valley Academy auditorium. Would be co-sponsored with GH Chamber. Moved and seconded by Mansker/Lyle. Motion PASSED unanimously.

Discussion and possible Board action to reassign GHSNC credit card. Moved/seconded by Mansker/Phillips for Dave Beauvais to be the second credit card holder. Because Mr. Beauvais is NC President, Brad Smith (Vice-President) will also review Treasurer's report.
