Environmental group – focused on preserving 15,000 acres of private land in west SFV. There are a number of developers eyeing this property. There are agreements in place to clean up Rocketdyne location to residential or background standards (Last rocket test in 2006 -- that's not the urgent issue). The urgency right now: Burrow Flats archeological district – Area 2 Basically there are two applications for this property: National Park Service and Chumash Native American tribe. SSMP thinks joint partnership may be the best solution for stewardship of this area. Referred to Rim of the Valley study. Hoping for National park in this area. GSA process is on a path to divest the federal government of this property; SSMPA wants to direct this process so the land goes to a joint stewardship by NPS and the Chumash Indians.

Motion moved and seconded by Carson/Luszczak to support the SSMPA efforts to have the NPS buy this property. Motion passes unanimously 15/0

Discussion and possible Board action to fund security improvements for Granada Hills Charter High School, not to exceed \$5,000. Motion moved by Brad Smith/second made by not recorded. Motion passes: 10/2/2

Discussion and possible Board action to support SOLID project to remodel the kitchen at Devonshire station in the amount of \$2000. Motion moved and seconded by Luszczak/Lopez. Freedman/Greschner motion to amend the amount to \$1500. Amendment passes 9/5. New amendment to lower the amount by \$1000 to \$500 moved and seconded by Crawford-Velasco/Freedman. Motion fails 3/11/1. Vote on main motion for \$1500. Question called by Askew/Schindleheim. 4 opposed. Vote taken on amended motion in the amount of \$1500. Motion passes: 11/4/0

Discussion and possible Board action to purchase 20 street pole banners and 10 replacement banners for outreach. \$5,300. Motion moved and seconded by Dunlap/Freedman. Motion carries: 15/0
