# **Approval of the Minutes**

Minutes of September 2013 Board Meeting were approved (Matthews/Greschner) by voice vote, Bursk, Lyle abstaining.

The chair noted Stakeholder William Kuzmin's objections to the accuracy of the PLUM motions.

#### **Public Comment**

Bonnie Bursk spoke on the Holiday Parade, scheduled for Sunday December 8<sup>th</sup>. The parade is organized by the Chamber of Commerce who are soliciting sponsors.

Melvin Canas introduced himself. He is the new DONE representative and will cover Chatsworth to Sunland. He will come to as many meetings as possible, although he noted that GHSNC meetings conflict with North Hills East. Several people spoke on the recent NC Congress. It had about 700 attendees and was very worthwhile. One item being promoted was the My LA 311 App for iPad and Android:

The semi-annual Neighborhood Council Budget Advocates meeting is to take place on October 26<sup>th</sup>, and the City Budget for next year wil be discussed. Our Budget reps are Krisna rawford-Velesco and Cindy Wu-Freedman.

It was noted that NC Elections, including those for this NC, are to be held in March. Planning for this is underway.

Preseident Beauvais noted that this meeting was being video-recorded by Mr Kuzmin.

Mr Kuzmin gave notice of a grievance to be filed against GHSNC. He is a shareholder and homeowner in the GHNC. He gave a partial overview of the grievance in the allotted time.

Monica Stevens and James Kuzmin, stakeholders, also presented aspects of the grievance.

Pamela Rhodes, Granada Hills Library manager, invited people to come and visit the library, which has been in operating for 51 years. It operates several educational initiatives including Obamacare, citizenship, nd financial literacy. She also discussed the Friends of the Library which is a fundraising organization, and thanks the community for their ongoing support.

### **President's Report**

Dave Beauvais noted the NC Congress, mentioned above.

Elections are forthcoming in March. There is a 45 day window for candidate announcements and applications. The Council needs to perform some election outreach.

Brad noted that the NC Working Groups (LANCC and VANC) were taking place this week.

# **Treasurer's Report**

Brandon also thanked all Board Members for taking the training required to vote on funding issues.

Brandon commented that he is now required to submit a list to DONE of all Board members who vote on a funding motion or an amendment, and which way they voted.

Motion to approve the Budget Report (Schindelheim/Mansker) carried unanimously.

### **Board Issues & Updates**

Motion to support the Recreation and Parks annual Halloween night, NTE \$500 (Lyle/Lopez) carried unanimously (14 voting).

[Mr Kuzmin rose to object to the agenziation of this meeting, stating that the notice was not posted in 5 locations open to the public 24/7 for at least 72 hours. Dave Beauvais noted that the Brown Act requires one location only, which in our case is Postal Plus, and all other posting locations are excess. Mr Kuzmin was issued a verbal warning not to disrupt the meeting.]

Motion to support the annual Granada Hills Holiday Parade, NTE \$2500 (Mansker/Kolstad). Jerry Askew recuses himself and leaves the hall. Bonnie Bursk presents the information and recuses for the vote.

The date for the parade is December 8<sup>th</sup>. It has about 4000 participants and is in its 30<sup>th</sup> year. The parade pays for competition judges so that the participating bands can get credit, which encourages a high standard of participation. (Bursk leaves the hall)

To meet DONE criteria which indicate that the Chamber itself is not an organization which can receive such funds, a motion to amend the motion was made (Mansker/Turmell) that the funds be used for banners featuring GHSNC. Amendment passes unanimously count 12. Motion as amended passes unanimously count 12 (Bursk/Askew having recused).

Kevin davis introdces Jose Castillo, principal of Patrick Henry Middle School, to seek support of the music program. Motion to support the program NTE \$1000 (Greschner/Mankser) passes unanimously count 14.

Various motions were made concerning the upcoming election in support of the required Election Stipulation:

- Election window: 6 hrs (Mansker/Bursk) unanimous.
- Location: Rec Center (Mansker/Lopez) unanimous.
- Backup location: Chamber of Commerce (Matthews/Wubben) unanimous.
- Voting period: 10am-4pm (Mansker/Turmell) unanimous

- Required documentation: Yes (Wall/Turmell), Greschner abstains, no NO votes
- Vote by Mail: No (Askew/Mansker) unanimous
- Overall vote unanimous 15 voting

Motion to support the VANC initiative to increase the allotted time for NC Members to address the LA City Council to five minutes. (Smith/Mansker). Amendment to change "Members" to "Board Members" (Bursk/Smith) carried unanimously. Main Motion carried unanimously.

### **Public Safety**

Recommend approval of motion from committee: Board letters seeking police support for Food Truck nights. Amendment (Askew/Mansker) to strike Wednesday and seek support for Fridays only, passes unanimously. Main motion passes unanimously.

There is a PAC study to put a stop sign at Chatsworth and Yarmouth.

Vote to approve report passes 15/0/1, Wu abstaining.

# **Planning and Land Use**

Presto Pasta Conditional Use Permit, held over to November

Support of the Mural ordinance's version "b": prohibition on murals within single-family residential. Expand prohibition to include all (including multi-family) residential uses. Add the following requirements:

- Anti-graffiti coating to be applied to all murals
- Create an ACE-style fee structure to aid enforcement
- Opt-in process to be based on Neighborhood Council boundaries and be subject to approval by the enclosing NC

Motion to support (Askew/Mansker) passes unanimously.
