Approval of the Minutes

Minutes of December 5, 2013 General Board Meeting were approved unanimously.

Public Comment

Rusty Feuer spoke about a local company that is putting many signs up on local telephone poles. Tania Oronoz from CD stated that this was a specific issue with a particular company and she is working with the DA on the matter.

Mr Kuzmin commented on the broadcast emails from GHSNC.

Community Speakers

Tania Oronoz from CD 12 announced that the Council is in recess. The big issue currently is the Community Care Ordinance. In addition, there are a variety of activities planned for the 20th anniversary of the Northridge earthquake. Tania is in possession of the Disaster Recovery Handbook; distribution will start by the end of the month.

Lynda Grant, BONC Commissioner, rose to status the Board on BONC activities. BONC welcomes comments on any issues at commissioners@empowerla.org. Lynda can be contacted directly at 818-470-6629, or Lynda.Grant@lacity.org.

Fire Chief John Drake came to discuss LAFD's new strategic plan, the first they have ever had. LAFD covers 470 square miles, 3.8 million people, and responds to 404,000 calls/year on a budget of \$550M. They ask stakeholders to respond to their survey at http://www.surveymonkey.com/S/LAFD. Their goal is to go from being reactionary to proactive.

Officer Reports

The treasurer presented his report. There is a new resource on the DONE website for Neighborhood Purpose Grants (NPG). There is \$7,000 remaining in the budget this year for these. DONE has contracted with Union Bank and GHSNC now has access to a checking account to help pay invoices. There is talk of the annual NC allotment being raised, maybe as high as its original amount of \$50K.

Motion to approve the Treasurer's report (Schindelheim/Bursk) unanimous.

Vice President Smith reported that the NC Working group is now working on 17 motions. Tonight, the Board will consider the first 9.

Board Issues & Updates

The matter concerning the synagogue plans for their parking lot was tabled to give the Board an opportunity to communicate with them. (Mansker/Luszczak, unanimous).

Motion to allot \$800 for bus bench advertising (Beauvais/Dunlap) passed unanimously.

The newsletters came out looking great. 11,000 we printed and mailed.

An Election Outreach meeting will be held in the new Valley Relics Museum on 1/8/14. Kevin Taylor encouraged stakeholders to run for office and to solicit other potential candidates. At this time, only one candidate has filed for GHSNC.

Dave Beauvais noted that more people are approaching the NCs for outreach (e.g. today's LAFD speaker, so they are started to get traction in the community.

Brandon Schindelheim reported that Valley Academy of Arts and Sciences has asked to use the GHSNC logo on its robot. Motion (Schindelheim/Wu Freeman) carried unanimously.

Anthony Matthews reported on the Grievance Panel activities. The report was presented by Jeffrey Bohrer. It will be submitted to the Executive Committee for preliminary review and recommendation. The Board thanked the panel for all their hard work.

Brad Smith presented the NC Working group motions for Board endorsement. The motions are shown in an addendum to these minutes. The results were as follows:

Planning and Land Use.

Valerie Sachs presented on behalf of Chipotle restaurant going in at Balboa and Devonshire. They are applying for a full alcohol license but only anticipate selling beer, wine, and marguaritas. Committee recommends support. After discussion, a motion was made to amend Board approval to require a sunset clause on ownership change, so that the license would not pass with the property if it was sold on. Motion to amend (Askew/Mansker) passed unanimously. Motion as amended passed 8/5/1.

Motion to adjourn 9.35 pm (Mansker/Hudson) unanimous.
