

**REGULAR BOARD MEETING MINUTES**, Thursday, February 3, 2022 Approved March 3, 2022

Granada Hills

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

GHSNC (and all other) Meeting Minutes are a summary; Minutes were not, are not and are never meant to be an exact, verbatim, word-for-word transcript or comprehensive record of what was said at a Meeting. Exceptions: Motions/Resolutions (as stated at the Meeting, which take precedence over versions written on the Agenda, if different); quotes (words that have quotation marks ("") at the beginning and ending of a word or words); and other wording from the Agenda such as the first paragraph(s) of some Items. Items are listed in and match the same order as on the Agenda.

#### I. Call to order, Flag Salute

President Mike Benedetto called the Meeting to order at 6:32 p.m. The Pledge of Allegiance was led by Jerilyn López Mendoza.

The next Agenda Item addressed was Item #IV. D.

### II. Roll Call (Secretary)

Roll Call was taken by the Secretary. Eleven of the 16 Board Members were present online at the Roll Call: Carlos Amador, Mike Benedetto (President), John Horn, Michael Jordan, George Karam, Christine LaMonica, Jerilyn López Mendoza, Carolyn Sanderson, Chantal Serrano, Brad Smith and Colleen Toumayan (Vice-President). Sally Kolstad arrived later. Four Board Members were absent: Launa Bogartz (Treasurer) (excused), Verej Isanians (unexcused), Abbey Ronquillo (excused) and Chavon Smith (excused). The GHSNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is nine (see the Bylaws link at <a href="https://www.empowerla.org/ghsnc">www.empowerla.org/ghsnc</a>), so the Board could take such votes. Sixteen of the 17 Board Seats were filled (by election or appointment). One Board Seat was vacant [At Large]; to apply, see <a href="https://www.ghsnc.org">www.ghsnc.org</a>. Also attended: at least 18 Stakeholders and Guests.

The next Agenda Item addressed was Item #IV. D.

Jill Mather [founder of "Volunteers Cleaning Communities" (VCC); JillMather@earthlink.net], described their upcoming cleanup. Stakeholder John Hales reported that "approximately 100 students" who did a "smash and grab" crime at Ralph's Market.

volunteered to be CIS (Community Impact Statement) filers. Mr. Cupen-Ames recommended Agendizing approval of CIS filers for the next Board Meeting.
