



CITY OF LOS ANGELES GRANADA HILLS SOUTH NEIGHBORHOOD COUNCIL **REGULAR BOARD MEETING MINUTES**, Thursday, March 3, 2022 Approved April 7, 2022

In conformity with the Governor's Executive Order N-29-20 (March 17, 2020) and due to concerns over COVID-19, this duly noticed meeting was held entirely online and telephonically.

GHSNC (and all other) Meeting Minutes are a summary; Minutes were not, are not and are never meant to be an exact, verbatim, word-for-word transcript or comprehensive record of what was said at a Meeting. Exceptions: Motions/Resolutions (as stated at the Meeting, which take precedence over versions written on the Agenda, if different); quotes (words that have quotation marks ("") at the beginning and ending of a word or words); and other wording from the Agenda such as the first paragraph(s) of some Items. Items are listed in and match the same order as on the Agenda.

I. Call to order, Flag Salute

President Mike Benedetto welcomed everyone and called the Meeting to order at 6:38 p.m. The Pledge of Allegiance was led by Chantal Serrano.

II. Roll Call (Secretary)

Roll Call was taken by the Secretary. Eleven of the 15 Board Members were present online at the Roll Call: Carlos Amador, Mike Benedetto (President), John Horn, Michael Jordan, George Karam, Sally Kolstad, Carolyn Sanderson, Chantal Serrano, Brad Smith, Chavon Smith and Colleen Toumayan (Vice-President). Launa Bogartz (who had resigned as Treasurer), Christine LaMonica and Abbey Ronguillo arrived later. Verej Isanians was absent. Jerilyn López Mendoza had resigned. The GHSNC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is nine (see the Bylaws link at www.empowerla.org/ghsnc), so the Board could take such votes. Fifteen of the 17 Board Seats were filled (by election or appointment). Two Board Seats were vacant [both At Large]; to apply, see www.ghsnc.org. Also attended: at least 24 Stakeholders and Guests.

III. Public Comment

Stephanie Clements, City Controller candidate, introduced herself and listed her priorities. Stakeholder John Hales commented on the Chatsworth TravelLodge project.

Board Member Launa Bogartz arrived online at this time (6:49), making 12 Board Members present online (the GHSNC quorum is nine).

Stakeholder Glenn Bailey reported that the next VANC [Valley Alliance of Neighborhood Councils; VANC@EmpowerLA.org; http://empowerla.org/vanc-2] meeting would be March 10th. Stakeholder Mark Hovater reported that pop-up sidewalk vendors "are now competing with our Grub Fest . . . right in front of our L.A. City sign."

Board Member Christine LaMonica arrived online at this time (6:57), making 13 Board Members present online (the GHSNC quorum is nine).

She reviewed COVID-19 Coronavirus safety masking guidelines. Public Ambassador Program trainings are available for students. Community Advisory Committee applications are being accepted from parents, staff and community members. A Young Men's Leadership class will be held in April.

 recommending that Board Members recuse if there may be a conflict of interest.
 Funding training is available. She indicated that she knows that the GHSNC
 approved having a CSUN intern; she consulted with the City Attorney and City
 Clerk Funding Unit and "will follow up."
- I. Budget Advocate (Brian Allen) Mr. Allen reported that the Budget Advocates [LABudgetAdvocates@gmail.com; www.BudgetAdvocates.org] "have met with most of the [City] Departments." There will be an April 10th City Controller candidates forum. The annual Budget Day will be Saturday, June 18th from 9:30 a.m. - noon.

Ms. Bogartz reviewed the September 2021 MER.

FUNDING MOTION (by Mr. Benedetto, seconded by Mr. Smith): The Granada Hills South Neighborhood Council approves the Monthly Expenditure Report for September 2021.

FUNDING MOTION PASSED unanimously by a roll call vote of the 13 eligible voters present with all 13 in favor ("Yes" or "Aye") (Amador, Benedetto, Bogartz, Horn, Jordan, Karam, Kolstad, LaMonica, Ronquillo, Sanderson, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Ms. Bogartz reviewed the October 2021 MER.

FUNDING MOTION (by Mr. Benedetto, seconded by Ms. Toumayan): The Granada Hills South Neighborhood Council approves the Monthly Expenditure Report for October 2021.

Board Member Sally Kolstad was unavailable to vote at this time, making 12 Board Members present online (the GHSNC quorum is nine).

FUNDING MOTION PASSED unanimously by a roll call vote of the 12 eligible voters present with all 12 in favor ("Yes" or "Aye") (Amador, Benedetto, Bogartz, Horn, Jordan, Karam, LaMonica, Ronquillo, Sanderson, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Ms. Bogartz reviewed the November 2021 MER.

FUNDING MOTION (by Mr. Benedetto, seconded by Mr. Horn): The Granada Hills South Neighborhood Council approves the Monthly Expenditure Report for November 2021.

FUNDING MOTION PASSED unanimously by a roll call vote of the 12 eligible voters present with all 12 in favor ("Yes" or "Aye") (Amador, Benedetto, Bogartz, Horn, Jordan, Karam, LaMonica, Ronguillo, Sanderson, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Board Member Sally Kolstad was again available to vote at this time, making 13 Board Members present online (the GHSNC quorum is nine).

Ms. Bogartz reviewed the December 2021 MER.

FUNDING MOTION (by Mr. Benedetto, seconded by Mr. Horn): The Granada Hills South Neighborhood Council approves the Monthly Expenditure Report for December 2021.

FUNDING MOTION PASSED unanimously by a roll call vote of the 13 eligible voters present with all 13 in favor ("Yes" or "Aye") (Amador, Benedetto, Bogartz, Horn, Jordan, Karam, Kolstad, LaMonica, Ronquillo, Sanderson, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Ms. Bogartz reviewed the January 2022 MER.

FUNDING MOTION (by Mr. Benedetto, seconded by Mr. Karam): The Granada Hills South Neighborhood Council approves the Monthly Expenditure Report for January 2022.

FUNDING MOTION PASSED unanimously by a roll call vote of the 13 eligible voters present with all 13 in favor ("Yes" or "Aye") (Amador, Benedetto, Bogartz, Horn, Jordan, Karam, Kolstad, LaMonica, Ronquillo, Sanderson, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Board Member Carlos Amador left at 8:45, making 12 Board Members present online (the GHSNC Board quorum was nine).

VIII. Board Issues

A. Need for Treasurer and Secretary Mr. Benedetto noted the need. Stakeholder Christina Wallis described her extensive financial services background and interest in being the Treasurer. Ms.

LaMonica agreed to become the Secretary.

B. Discussion and possible support for a liquor license for the Grocery Outlet at 11130 Balboa Blvd., Granada Hills. Project representative Steve Rawlings presented and showed slides. They have three Grocery Outlets in the San Fernando Valley. The store at Balboa and San

Fernando Mission Blvd. will have "improvements on the exterior of the buildings."

Board Member Launa Bogartz left at 9:02, making 11 Board Members present online (the GHSNC Board quorum was nine).

Pat Barber, of Grocery Outlets, said it's a 75-year-old, 450-store discounter with major brands. They have an "independent operator model" and though "Grocery Outlet pays the rent and other expenses . . . it's not a franchise . . . we split the gross profit" while the independent operators "run the stores." He said "there's plenty of parking . . . we hope to open by the end of the year." Operating hours would be "no earlier than six a.m. in the morning and no later than 11 p.m. at night." Brian Allen was concerned that already there is a lot of traffic and it is "extremely difficult to get in and out of this lot"; he asked the developer to "do a lot more research on the traffic." Mr. Barber believed that Trader Joe's traffic won't overlap with Grocery Outlets'.

MOTION (by Ms. Toumayan, seconded by Mr. Horn): The Granada Hills South Neighborhood Council supports a liquor license for the Grocery Outlet at 11130 Balboa Blvd., Granada Hills.

MOTION FAILED by a roll call vote of the 11 eligible voters present with four in favor ("Yes" or "Aye") (Horn, LaMonica, Serrano and Toumayan); five opposed ("No" or "Nay") (Jordan, Kolstad, Ronquillo, Sanderson and Brad Smith); two abstained (the GHSNC does not count abstentions as either "yes" or "no" votes) (Benedetto and Karam).

There was extensive discussion of whether to refer this to a Committee.

MOTION to RECONSIDER (by Ms. Ronquillo, seconded by Mr. Smith): The Granada Hills South Neighborhood Council will RECONSIDER Item #VIII. B.

MOTION to RECONSIDER PASSED by a roll call vote of the 11 eligible voters present with eight in favor ("Yes" or "Aye") (Benedetto, Horn, Jordan, Karam, LaMonica, Ronquillo, Serrano and Toumayan); three opposed ("No" or "Nay") (Kolstad, Sanderson and Brad Smith); zero abstained.

Mr. Smith declined to have the Public Safety Committee take up this issue. Mr. Benedetto, noting that the GHSNC currently didn't have a functioning Planning and Land Use Management Committee, "will speak to DONE."

C. Deodar trees: update

There was an update about the Cedar Deodar trees; also see above Item #IV. F.

D. ABLE training

Mr. Benedetto reminded those who haven't to complete the training.

E. Bylaw committee – set up a meeting

Mr. Benedetto noted the need for the above.

Board Members Carolyn Sanderson and Michael Jordan left at 9:37. making eight Board Members present online, short of the GHSNC Board quorum of nine.

FUNDING MOTION PASSED unanimously by a roll call vote of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Benedetto, Horn, Karam, Kolstad, LaMonica, Ronguillo, Serrano, Brad Smith and Toumayan); zero opposed; zero abstained.

Board Members Chantal Serrano left at 9:43 and Michael Jordan soon after that. making six Board Members present online, short of the GHSNC Board quorum of nine.

B. Discussion and possible action for GHSNC to host a Movie Night at the Granada Hills Recreation Center on May 28th, not to exceed \$2,000.
