A. Discussion and possible recommendation to the Board regarding a request to support the following council file on street racing; see CF-21-0975: Illegal Street Racing / Reckless Driving Exhibition / Spectator Gathering / Promotion / Facilitation. (See Exhibit A)

DRAFT Motion to support as follows:

The Granada Hills South Neighborhood Council unanimously wishes to express its endorsement and support for Council File 21-0975 (Lee-Rodriguez). Street racing and intersection takeovers have become a chronic issue in Granada Hills and throughout Los Angeles. Adding penalties that criminalize the promotion of illegal street races and side shows by making it a misdemeanor to knowingly encourage, promote, instigate, assist, facilitate, aid or abet the gathering of persons as spectators at these events making it punishable by a fine and or imprisonment is a good step towards reducing the dangers, nuisance, and damage caused by these actions.

- B. Discussion and possible recommendation to the Board regarding a new Community Emergency Response Team (CERT) course sponsorship. GHSNC has sponsored or co-sponsored CERT training programs, in concert with the city of Los Angeles in the past. GHSNC President Mike Benedetto has requested we do so in the future. This would require purchase of the CERT Basic Kit for the trainees. See attached bid (Exhibit B-1 and B-2), provided by SOS Survival Products (Van Nuys, CA) Mr. Benedetto, as of Oct. 9, 2021. Bid is \$839.891 for 48 kits. Potential motion by the committee to allocate up to \$900 from GHSNC budget for said purchase, and to move forward with coordinating a CERT training program as practical.
- C. Discussion and possible recommendation to the Board regarding support of the GHSNC and GH BID deodar trees project(s). Information from Carlos Amador,

Beautification Committee chair: "spoke with Susan Levy from the Business Improvement District. She asked me if I knew when the city was going to do their deep watering so they could schedule their session with a landscape company either before or after ours. I told her that (GHSNC President Mike Benedetto was) going to contact the city council office and that I would let her know once I knew more information. But, I think it is reasonable to assume that the city deepwatering session won't happen in the coming weeks. Therefore, she is going to move forward and have their private landscape company do their sessions in the next four weeks. I think this provides enough time to have the city lined up and do their watering next week. If (the GHSNC President hasn't) reached out to the city council office ... please do so at the earliest convenience? For ... reference, here is the information provided by Scott Harmon. Supervisor in the Forestry Division, for the watering of the trees: The total cost for the watering crew per day is \$3864.00. That includes 3 watering truck rigs and 6 employees for 10 hours which is what you would need to provide the watering of the trees along White Oak Ave. The goal is to deep water all the trees from Mayall to San Fernando Mission Road, on White Oak Avenue." Motion to support Beautification Committee in their effort to move this project forward and coordinate with the BID to maximize effectiveness of this effort.
